## MINUTES OF THE 2008 AGM

held on 4 December 2008 were approved.

Moved: Tony Weber, Seconded Al Bart

Motion carried unanimously

Most actions arising are reported on later in these minutes. Other activities include: Meeting with Simulation Industry of Australia – this is a very large and well-organised group. The Executive met with them in late December and both groups have agreed to maintain an informal dialogue (mainly to ensure that we complement each others activities).

Corporate membership – while this was discussed as a way of gaining sponsorship, good sponsorship was received for MODSIM09 without it. On the backburner.

#### PRESIDENT'S REPORT

The President, Tony Jakeman, reported on several activities that were foreshadowed at the 2008 AGM, and other MSSANZ happenings. Some key points to note:

• One of our distinguished medalists, Sir Clive Granger, died this year. An award is to be named in his honour – see later agenda item.

- Noted that impact factor for the journal "Environmental Modelling and Software' is now 2.659 (up from 1.992 in 2006). Tony believes this is largely due to (i) scope tightening – fewer straight application papers (unless they provide insights) with more generic articles which have greater impact; and (ii) good body of reviewers (great support from the MODSIM and iEMSs communities)
- IMACS run 3 journals. Michael McAleer and Les Oxley have been editing special issues of one of them for the last few MODSIMs.
- MODSIM proceedings (up to 2003) are now listed by Thomson-Reuters (their current policy is restricted to printed copy, and 2003 was the last printed proceedings). Waiting for them to upgrade their policy to accept online proceedings; alternative is that we print one set and send to them.
- Corporate member of the Society is being investigated by the Executive.

Tony thanked Peter Manger, Tony Weber and Lachlan Newham for their great work on WCMT and the members also expressed their vote of thanks.

## WCMT (Web Conference Management Tool)

Lachlan Newham felt that the Society should make further investment in WCMT for 2011. The main developments since MODSIM07 were to improve the functionality for stream organizers; next is to upgrade the convenors' tools. It was noted that there is coinvestment with iEMSs in WCMT maintenance and development, and keen to expand the community (e.g. IMACS).

Noting that there is significant IT knowledge required to host WCMT, MSSANZ has purchased a server so that WCMT can be hosted from MSSANZ in future.

## TREASURER'S REPORT

Lachlan Newham tabled a draft set of accounts (statement of income & expenditure and financial position) at 30 June 2009.

Motion: "that the financial statements be accepted."

The Treasurer has been investigating the establishment of a Sinking Fund to (1) cover a catastrophic failure of a conference and (b) to have a steady stream of income for activities such as WCMT.

#### Motion as amended:

"that a new Clause 36 be added to the Constitution to read:

- (1) A sinking fund is to be established and maintained for the Association by the Treasurer.
- (2) The fund is to be limited to capital-guaranteed investments not exceeding twovears duration.
- (3) Interest earnings from the sinking fund will be allocated in equal proportion to the
- (i) sinking fund for reinvestment and (ii) funds of the Association.
- (4) The capital of the sinking fund can only be withdrawn in emergency financial situations. Withdrawal of the funds requires approval of all of the following (a)


The position of Public Officer is ongoing, until such time as the Public Officer stands down.

#### 2. MEMBERSHIP OF MAILING LIST

#### 3. COMPOSITION OF 2010/2011 AWARDS COMMITTEE

The President foreshadowed a proposal to extend the Committee to include more disciplinary fields (e.g. ecology, social science, hydrology). Members agreed with this sentiment, on the proviso that the members were drawn from MSSANZ Fellows who were active in the Society.

Motion

'that the current Awards Committee have the power to co-opt up to two more members taking account of disciplinary structure and the balance of the Committee' Moved – Roger Braddock, Seconded – Freeman Cook

# 4. OPTIONS FOR PRESENTATION OF PAPERS AT MODSIM FOR AUTHORS WITHOUT FULL PAPERS

MODSIM 09 was the first time that abstracts were published without full papers. The impact of this was discussed at the meeting, with an alternative suggestion that poster papers be introduced to attract researchers, particularly from industry and those disciplines that don't have a culture of full papers. Members were strongly of the opinion that one of the main attractions of MODSIM is the quality of the referred papers.

#### Motion as amended

'that MODSIM introduce poster sessions which only require a one-page abstract (published in proceedings) and poster, while retaining the requirement that an oral presentation requires submission of a full referred paper'

Moved - David Post, Seconded - David Mayer

Members agreed in principle that the different style of presentation had merit and requested that a working group investigate the practicality (such as changes required to WCMT, refereeing process). A working group was formed of Andre Zerger, Dora Marinova, David Post and Lachlan Newham.

#### **BUSINESS ON NOTICE**

#### 1. Proposal for Clive Granger award

Clive Granger was professor at Universities of Canterbury and Melbourne, and had been an active and very distinguished member of the Society, a Biennial Medallist in 2001 and attended most sessions at MODSIM07.
